## **Practice Learning Line of Sight Event - Children living with** domestic abuse

As a joint priority with the Community Safety Partnership, the Practice Learning Line of Sight event aimed to contribute to the shared outcomes so that individuals are safe, strong and resilient and that people are enabled to recover and withstand adverse effects by reducing the impact of domestic abuse.

## 3 Good practice

- The importance of relationships evidenced through strong relationships between practitioners with children and families also good multi agency working relationships and collaborative working across agencies
- Children, young people and families are at the centre – enables a personalised approach, where work is structured around the needs of the family
- The impact of individuals tenacious approach is making a difference
- Good use of evidence based practice and expertise

#### **Key learning**

- Further training on specific aspects of domestic abuse
- Resources and bespoke programmes needed for non-convicted perpetrators to effect change when families wish to remain together
- Continue prevention work with children and young people to break the cycle

- Education and training continues to be further developed relating to recognising the signs of coercive control and behaviours also honour based abuse
- A flexible non-convicted perpetrator programme has been developed to work with perpetrators, victims and children within a multi agency context and this will be implemented over the next year so that families get safe, stay safe and become independent of services
- We continue to further develop prevention work including a focus on helping children and young people in domestic abuse households understand healthy relationships to break the cycle of intergenerational abuse
