Learning from practice

Key themes from the Multi-Agency Reflective Practice Forum (MARPF)

The MARPF is held on a monthly basis to reflect on practice, based upon prior single agency audit and quality assurance. A summary of the strengths and learning highlighted at the MARPF this quarter includes:

- Evidence of positive approaches taken by professionals to work with the child.
 An example of this is a considered approach by the three trusted professionals in identifying who was the best person to address issues rather than three people visiting (thus preventing duplication and demonstrating fewest best interventions)
- The child was given autonomy in choosing who she wanted to speak
- The child's placement move was managed in a timely manner. Practitioners worked to ensure she stayed as local as possible to ensure she could continue family time and remain as close to her family and community as possible
- The MARPF reflected around the parent's own adverse childhood experiences and how this impacted on her parenting style. The importance of considering this and supporting parents to access support was crucial to move forward in a positive way
- The discussion identified that it is challenging for professionals to work with families who do not want to work with services before a crisis point is reached

Dr Emma Katz - Understanding coercive control and its impacts on children

Join us in welcoming Dr Emma Katz for this webinar on coercive control and its impacts on children, which is taking place on 10 October, 10.00 to 11.00, MS Teams.

Dr Emma Katz is Associate Professor at Durham University. She is an award-winning expert in domestic abuse and coercive control, whose work has influenced policy and professional practice in the UK and globally.

Dr Katz's book, Coercive Control in Children's and Mothers' Lives (published in 2022 by Oxford University Press) is described by Professor Evan Stark as a 'pioneering work that will change how we understand and respond to children's experience of domestic abuse'.

Partnership Group Updates

Children's MARS subgroup updates

Key Updates - Early Help Strategic Leads Group (EHSLG)

- Following the discussion and resulting actions from the last Children's MARS Board about early help and the need for a more focused response from the lead officer group, the Early Help Strategic Leads Group dedicated the February meeting to exploring front door data and developing a work plan for the year ahead
- A specific multi-agency forum for reviewing the inappropriate calls to the Single Point of Contact was established. This aims to help develop a more sophisticated understanding of early help practice and the drivers for the increase in calls over the last year. The meeting was well attended by lead officers representing education, social care, CAMHS, adult services, and the 0-19 health and wellbeing service. The group explored a number of calls from a range of sources and key themes were reported into the Children's MARS Board
- This year has seen the implementation of a new assessment model, plan, and recording mechanism in October 2022. Secondly, there has been a change in practice meaning that single-issue early help assessments aimed at building evidence for an EHCP process has ceased. Thirdly, the new system registers early help closures, as well as those being started, meaning that the new data is far more accurate than in previous years. Overall, the level of confidence we can have that early help plans are whole-family and actively being reviewed has risen over this year
- The EHSLG has led on the development of an early help work plan for 2023/24, which is in the process of being populated with lead names and timescales for approval at the next meeting

Key Updates - Children's Help and Protection Pathway (CHaPP) Group

- The strong data report provided assurance that the vast majority of performance and activity indicators relating to the early help and protection system continues to show sustained high performance and compliance with local practice standards and statutory timescales for Q3
- Lead officers welcomed the addition of the community midwife to the CHaPP and heard the positive developments in relation to interagency working and contribution within the help and protection system as this had been area for consideration in quarter 2. Specifically, it was highlighted as good practice that communications have been strengthened with the NLaG Safeguarding Team and NICU Ward Managers around discharge planning arrangements for babies
- We Are With You updated the CHaPP in respect of their staff whom work specifically with families within the child in need and child protection arena. The ambition is to expand into prevention and be able to support families within early help. Good practice examples of improving engagement by building relationships, being out and visible in the community and being able to support parents to attend appointments were shared

Key updates - Risk Outside the Home Strategic Group

- The group has refocused to ensure there is appropriate assurance around key issues. A new reporting process has also been implemented with reports from area leads being required prior to the meeting to allow for discussion and challenge
- Work is being undertaken by the Child Exploitation Lead Officer Group (CELOG)
 to analyse vulnerabilities for children and link these to the available
 intelligence on them, therefore ensuring we are maximising all opportunities
 for disruption and support
- Missing children numbers are higher than the previous year but still
 significantly lower than in the years prior to the pandemic. A thematic analysis
 of missing incidents was undertaken in February, and it was identified that the
 increase in figures was due to a natural progression and removal of COVID
 restrictions. Assurance had been provided from the Children in Care Teams
 that all missing episodes are regularly reviewed and return interviews are
 taking place as required
- The ROTH Strategic Group meeting in March also received a comprehensive update on PHSE with a focus on Sex and Relationship Education and healthy relationships. Safeguarding Leads from two local schools attended to give an overview of their PHSE offer
- The ROTH delivery plan for 2023-24 is in development and will focus on key areas of added value and identified areas for further development some of which include transitions to adulthood, working with hotels, bars and taxi companies and the development of safe spaces
- The Board also heard updates on a specific police operation relating to child criminal exploitation and the plans in place relating to disruption activity. A bespoke ROTH Strategic Group is to be convened to consider the partnership response to this


Key updates - Safeguarding Practice Learning and Improvement Group

- The Board heard that a SPLIG development session was scheduled for May 2023 to consider the implications from the reports issued by the Child Safeguarding Practice Review Panel including their briefings on bruising in nonmobile infants and multi-agency safeguarding and domestic abuse
- The above session will also have a focus on previous reports issued by the Child Safeguarding Practice Review Panel to provide lead officers with an opportunity to reflect on whether the learning has been embedded

Key updates - Safeguarding children in education

- The outcomes of the annual schools safeguarding audit was presented to the Board. Audits were returned from schools (including special and independent) in North Lincolnshire, colleges in North Lincolnshire, alternative provision utilised by North Lincolnshire Council and out of area provision that North Lincolnshire children attend.
- The audit provides a high level of assurance that schools and settings in North Lincolnshire are meeting their statutory duties. It is also an opportunity for schools to evidence their good practice and identify any areas for development
- The outcomes of the annual safeguarding audit for the private, voluntary and independent childcare sector was presented to the Board. The audit was returned by childminders, nurseries, pre-schools and before and after school care. The analysis of the responses provided assurance to the Board that in all cases children are being effectively safeguarding in early years settings
