Every VCFSE and private sector organisation or agency should be aware of how they need to work with the safeguarding partners in a local area. Charities (within the meaning of section 1 Charities Act 2011), religious organisations (regulation 34 and schedule 3 to School Admissions) and any person involved in the provision, supervision or oversight of sport or leisure are included within the Relevant Agency Regulations¹⁸⁸. This means if the safeguarding partners name them as a relevant partner they must cooperate. Other VCFSE, faith-based and private sector organisations not on the list of relevant agencies can also be asked to co-operate as part of the local arrangements and should do so [Working Together 2023]
