Children's MARS Resilience and Safeguarding in Practice Event

The Children's MARS Resilience and Safeguarding in Practice event took place in November 2023. The event was an opportunity to bring together practitioners and local leaders at all levels who have responsibilities to safeguard and promote the welfare of children. As well as having a focus on our local arrangements, there was input from two national speakers who helped us to reflect upon local practice.

Key national guidance and policies

The government published the Working Together to Safeguard Children 2023: A guide to multi-agency working to help, protect and promote the welfare of children on 15 December 2023.

Alongside this statutory guidance, the government also published a revised copy of the <u>Working Together to Safeguard Children: Statutory Framework</u> and a <u>Summary of Changes document</u> which provides a brief summary of the changes to each chapter of the guidance.

Learning from practice

Key themes from the Multi-Agency Reflective Practice Forum (MARPF)

The MARPF is held on a monthly basis to reflect on practice, based upon prior single agency audit and quality assurance.

A summary of the strengths and learning highlighted at the MARPF this quarter includes:

- The case was extremely child focussed with professionals listening and acting upon her reported lived experiences
- There was significant management oversight and specialist independent advice was accessed from a national organisation
- After intervention, the child is flourishing, achieving and aspiring in her family, college and community
- The MARPF recognised that the level of professional curiosity in the early days of understanding the family dynamics could have been strengthened

The learning from the MARPF was shared with the Safeguarding Practice Learning and Improvement Group for further consideration.

Children's MARS subgroup updates

Key Updates - Early Help Strategic Leads Group (EHSLG)

- The number of early help assessments being undertaken and recorded on the system continues to be very strong. The overall number in 2022/23 was 743 which was the highest in 6 years, and the data from Q1 in 2023/24 indicates that this year will be at a similar level
- The rise in early help assessments is a significant achievement given that a
 new format for the assessments and a new recording system have been
 implemented during the previous year. The data now includes assessments
 completed by the council's family support service, and there is an ambition
 over time to also incorporate youth justice and health visitor assessments
 in the data to give an even more joined up picture of early help
- Bi-monthly multi-agency Single Point of Contact (SPOC) review meetings have been established to dip-sample and reflect on the decision making and offers of early help for children and families referred into SPOC which did not result in a specialist service being offered. The themes and identified learning from these reviews are being fed into the EHSLG to provide the group with a richer understanding of the behaviours and issues underpinning calls to the team
- A 7-minute briefing on early help is now available on the Children's MARS
 website and work is nearing completion on an animation aimed at
 explaining the early help process to families to help remove anxieties and
 barriers that reduce access to formal support
- The EHSLG has given focus over recent meetings to how we can improve
 the quality of early help practice. The new training offer has been key to
 this, with feedback from attendees consistently referencing the usefulness
 of the input around how to engage and build trust, encouraging family-led
 planning

Key Updates - Children's Help and Protection Pathway (CHaPP) Group

- The CHaPP received detailed analysis of data with exception reporting and some qualitative analysis. The strong data report assured that the vast majority of performance and activity indicators relating to the early help and protection system continues to show sustained high performance and compliance with local practice standards and statutory timescales
- The offer to children and families in North Lincolnshire continues to ensure that needs are met at the lowest level through the fewest and best interventions aligned to Working Together, national legislation, and local policy and procedure. Intervention with children and families is aligned to the values and principle of OFA in ensuring children thrive within their families, achieve within their schools and belong to their community
- The CHaPP heard updated from key health partners on recent developments including the new RDaSH offer for parents to receive bespoke additional support for crying babies by self referral and midwifery's strengthened approach to early help


Key updates - Risk Outside the Home Strategic Group

- The profile for the last quarter is very comprehensive and gives a good overview of the current situation. Data is showing that, the number of children at risk of CSE and their age demographic remains stable. However, there has been a marked shift to online investigations around child sexual exploitation
- There continues to be a strong focus on keeping young people in school
 with extensive work in place to encourage school attendance which
 included training on the Attend Framework. There is are mechanisms in
 place to communicate current themes and risks to Designated
 Safeguarding Leads in schools. Schools are actively trying to find other
 ways to address children's behaviour when they have been identified as at
 risk in their community
- There remains strong evidence of police and partner focus on disruption and dismantling the associated Organised Crime Groups. Risks around members of the groups remain but have been reduced and comprehensive plans are shown to be in place
- There was strong evidence of creativity in engagement, support for the families and progression of Child First principles with excellent challenge around the potential use of secure accommodation. The One Family Approach and focus on keeping young people in their families and in the community was evident.
- MACE continues to meet and is well attended and is complimented by location-based meeting, which focus on specific groups and geographic areas. Emerging themes are fully explored and have robust actions to mitigate risk. Current challenging themes relate to specific identified geographic areas, changes in the nature of substance misuse and concerns around associations. All of these themes are being explored further with specific responses and continued collating of intelligence and evidence.

Key updates - Safeguarding Practice Learning and Improvement Group

- A briefing was shared that sets out some key learning on thematic child safeguarding practice reviews that have taken place across the country in relation to the Joint Targeted Area Inspection to determine whether anything further needs to be done
- The SPLIG took account of the evaluation report from the Yorkshire and Humber Multi-Agency Safeguarding Trainers Group relating to the child sexual abuse webinar series that took place in July
- The SPLIG data report evidences that training continues to be delivered to a high standard and feedback remains overwhelmingly positive
- The outcomes from the annual review of the Children's MARS Arrangements
 was highly positive in relation to learning and improvement and was
 complementary of the quality of resources on the Children's MARS website
- Updates in relation to the Stay Safe Conference was provided to the group.
 The event was an opportunity to share key information with children on how to stay safe in their homes, schools and communities. Workshops included internet safety, community safety and child exploitation
- A representative from the Humberside Police Domestic Abuse Safeguarding Investigation Team attended the meeting to provide a presentation on the Domestic Violence Disclosure Scheme (Clare's Law) to raise awareness of the process and criteria across the partnership
